02	<p>Curriculum Assessments</p> <p>In Life skills and Arts & Culture, <u>Music</u> and <u>Dance</u> will be assessed as part of the school's curriculum. <u>This is not optional.</u></p>
03	<p>Language of Instruction</p> <p>This school is an English-medium institution. The language of instruction is English (learners are taught in English only).</p> <p>This school is equipped with human resources to cater for learners whose mother tongue or <u>chosen language of instruction is English.</u></p> <p>Afrikaans is a compulsory first additional language at this school and Zulu is a second additional language in Foundation Phase.</p>
04	<p>Storage and Handling of Personal Information</p> <p>We, as parents and the applicants, accept that the information provided to the school is given voluntarily and that the school may:</p> <p>Store the data in its files and electronic systems (hard copy and electronic copy).</p> <p>Generate academic, attendance, behavioural and other school-related records based on the information given</p> <p>Use both the provided and generated data for purposes of providing services relevant to the enrolment and progress of the applicant (including, but not limited to contacting parents; placing the applicant in a class; entering him/her in exams, competitions, leagues, etc) updating the school roll and alumni register; and researching and reporting on school demographics or performances).</p> <p>Pass it on where required to do so as part of school reports, testimonials and confidential reports, and for statistical or research purposes, or when legally required to do so.</p>
05	<p>Child-Care</p> <p>We understand and confirm that all staff members are duly authorised to act in loco parentis in any matter at any time during which I/we have entrusted our child to the care of the school.</p>
06	<p>Entry Level Age Stipulations</p> <p><u>Applicants need to be turning 6 in the year of grade R and turning 7 in the year of grade 1.</u></p>

Commitment to pay school fees

Emmarentia Primary is a fee-Paying School

Bursaries and Subsidies are not offered at Emmarentia Primary School.

<p>This form serves as a binding agreement between Emmarentia Primary School and the parents of the learner in terms of the South African Schools Act 84 of 1996, sections 39, 40 and 41 outlining the obligations regarding school fees and related matters.</p>	
<p>“Parent” means (a) a natural parent or guardian of a learner; (b) a person legally entitled to custody of a learner; or (c) a person who undertakes to fulfil the obligations of a person referred to in paragraphs (a) and (b) towards a learner’s education at school. Wherever the singular is used in this Agreement, it shall be construed as including the plural, and vice versa, unless specified otherwise.</p>	
1	School fees are due at the start of the academic year, with discounts available. If not paid in full, parents can opt for a payment plan of 10 equal instalments from January to October, with no extensions. Payments due on the 7th of each month. eg. January fees are due by 7 January, February fees are due by 7 February, March fees are due by 7 March etc.
2	If payments are not made as agreed, the full balance of the school fees will be due immediately. The school may take legal action if needed to protect its financial stability.
3	By signing this agreement, parents agree to a credit check if needed. If fees remain unpaid after several attempts to collect them, your name may be reported to a credit bureau.
4	Parents choose both their physical address specified as their residential address AND their email address/es contained in this document as their chosen legal domicile for service of all legal notices and processes. In event of a change, parents are to notify the school in writing of any new addresses or emails, which will then become the new legal domicile.
5	Parents must pay mandatory school fees according to the South African Schools Act. Both biological and adoptive parents are responsible for these fees, no matter their marital status or any legal, written or verbal agreements.
6	Parents facing financial hardships, such as losing a job, must inform the school right away to discuss alternative arrangements or exemptions at the start of the year.
7	This contract remains effective until the learner graduates or it is officially terminated per School provisions.
